-it will be forbidden to roll.

-the ball will always be put into play from the center of the field, even when one of the two teams has scored a goal.

-if, at the end of the 5 minutes foreseen for each game, the ball is still in play, the team will wait for the end of the game.

-If, at the end of the 5 minutes foreseen for each game, the ball is still in play, we will wait for the end of the game with a goal by one of the two teams.

-The team winning the game will advance to the round; the team losing the game will be eliminated.

-The members of the team that will have won the last game will challenge each other in a "one-on-one" game: the player who will win this game will be proclaimed the winner of the tournament.

-The player who will win this game will be proclaimed the winner of the tournament and therefore of this competition.
